

Privacy Policy

Updated 27/05/2016

NTAXI Limited respects the privacy of its users and is committed to the protection of all personal information. To access the services offered by NTAXI through its website or through mobile applications, users must provide personal information as requested in the online booking process.

In order to receive information about your Personal Data, the purposes and the parties the Data is shared with, contact the Owner. This policy refers to NTAXI, released as a part of NTAXI service.

Data Controller and Owner

NTAXI Limited is a Cyprus registered company with its business address at 7A Zinas Kanther, 3035 Limassol, Cyprus, acting as an Owner. NTAXI application is a product of Multi Brains LLC (“Multi Brains”). Multi Brains OÜ (Multi Brains LLC), the company incorporated and registered in Estonia with registration address in Kaubamaja 6-13, 10143 Tallinn, acting as a Data Controller. Multi Brains is committed to protecting and respecting the user’s privacy, on behalf of NTAXI Limited.

Types of Data collected

The owner does not provide a list of Personal Data types collected.

Other Personal Data collected may be described in other sections of this privacy policy or by dedicated explanation text contextually with the Data collection.

The Personal Data may be freely provided by the User, or collected automatically when using this Application.

Any use of Cookies – or of other tracking tools – by this Application or by the owners of third party services used by this Application, unless stated otherwise, serves to identify Users and remember their preferences, history of transactions for the sole purpose of providing the service required by the User.

Failure to provide certain Personal Data may make it impossible for this Application to provide its services.

Users are responsible for any Personal Data of third parties obtained, published or shared through this Application and confirm that they have the third party’s consent to provide the Data to the Owner.

Information NTAXI may collect from you

NTAXI may collect and process data about you relating to:

- the provision of services or online content in order to deal with your requests and enquiries. This includes data provided at the time of subscribing to any services NTAXI offers, downloading data posted on the Site, the Apps, Dispatch Panel and/or Company panel, posting material or requesting further services;
- data in connection with participation in any promotions or competitions sponsored, promoted or offered by us and/or any third party and any data provided to us by way of feedback, profile forms or site issues;
- your contacting us, for example by email, post or telephone, in which case NTAXI

may keep a record of that correspondence to respond to your enquiries and improve its services. Thereafter, NTAXI may use your email address to contact you about its services;

- other information from your interaction with the Site, the Apps, Dispatch Panel and/or Company panel, services, content and advertising, including computer and connection information, statistics on page views, traffic to and from the Site, ad data, IP address, standard web log information and the resources that you access, whether this is required for NTAXI own purposes or otherwise.

Mode and place of processing the Data

Methods of processing

The Data Controller processes the Data of Users in a proper manner and shall take appropriate security measures to prevent unauthorized access, disclosure, modification, or unauthorized destruction of the Data.

The Data processing is carried out using computers and/or IT enabled tools, following organizational procedures and modes strictly related to the purposes indicated. In addition to the Data Controller, in some cases, the Data may be accessible to certain types of persons in charge, involved with the operation of the site (administration, sales, marketing, legal, system administration) or external parties (such as third party technical service providers, mail carriers, hosting providers, IT companies, communications agencies) appointed, if necessary, as Data Processors by the Owner. The updated list of these parties may be requested from the Data Controller at any time.

Place

The Data is processed at the Data Controller's operating offices and in any other places where the parties involved with the processing are located. For further information, please contact the Data Controller.

Retention time

The Data is kept for the time necessary to provide the service requested by the User, or stated by the purposes outlined in this document, and the User can always request that the Data Controller suspend or remove the data.

Additional information about Data collection and processing

Legal action

The processing of personal data in Cyprus is governed by the Processing of Personal Data (Protection of the Individual) Law, which entered into force on the 23rd November 2001 to address privacy issues arising out of the collection, storage, processing and use of personal data. The Law was amended in 2003 in order to harmonise Cyprus legislation with the Directive of the European Union (95/46) on the protection of individuals with regard to the processing of personal data.

The User's Personal Data may be used for legal purposes by the Data Controller, in Court or in the stages leading to possible legal action arising from improper use of this Application or the related services.

The User declares to be aware that the Data Controller may be required to reveal personal data upon request of public authorities.

Additional information about User's Personal Data

In addition to the information contained in this privacy policy, this Application may provide the User with additional and contextual information concerning particular services or the collection and processing of Personal Data upon request.

System Logs and Maintenance

For operation and maintenance purposes, this Application and any third party services may collect files that record interaction with this Application (System Logs) or use for this purpose other Personal Data (such as IP Address).

Information not contained in this policy

More details concerning the collection or processing of Personal Data may be requested from the Data Controller at any time. Please see the contact information at the beginning of this document.

The rights of Users

Users have the right, at any time, to know whether their Personal Data has been stored and can consult the Data Controller to learn about their contents and origin, to verify their accuracy or to ask from them to be supplemented, cancelled, updated or corrected, or for their transformation into anonymous format or to block any data held in violation of the law, as well as to oppose their treatment for any and all legitimate reasons. Requests should be sent to the Data Controller at the contact information set out above.
